The HFEA charge CARE a fee of £37.50, this fee is levied on treatments involving the use of donor sperm. This levy is charged to the patient in addition to the costs outlined above. 3. The HFEA charge CARE a fee of £75, this fee is levied on completed IVF, egg recipient, egg sharer, surrogacy and FER treatments. This levy is charged to the patient in addition to the costs outlined above. 4. Patients undergoing treatments, which involve the receipt of donated eggs or surrogacy, will be charged for mandatory screening in certain cases. Individuals will be advised of those tests required at their initial consultation. A separate price list is available on request. 5. In known donation arrangements the fee excludes the costs of the donor's consultation, drugs and screening tests, which are the responsibility of the recipient couple. 6. Treatments that include an egg collection include the price of a sedation anaesthetic at egg recovery but not at embryo transfer. |

Payment Options

In order to keep costs down, patients are required to pay consultation fees on the same day. Treatment fees must be paid in full on the first day of monitoring, failure to complete payment at that time may jeopardise treatment. Cash, cheques or credit cards are accepted, personal cheques can be accepted up to the value of the guarantee card. Our preferred method of payment is by debit card (no charge) or credit card (1.5% charge).
